# Primary Spinal Primitive Neuroectodermal Tumor: Case Series and Review of the Literature

#### Abstract

Primary spinal primitive neuroectodermal tumor (PSPNET) is extremely rare and only 25 cases have been reported in the world literature so far. Three patients of 8, 9 and 18 years of age, who presented with variable grades of neurological deficit were diagnosed as having a dorsal intramedullary lesion, a holocord lesion and cervical extradural tumor with extraspinal extension, respectively, and were operated at our institute. The histopathology of all 3 children revealed PNET. The clinical course, image characteristics and outcome of the 3 children are described, and the relevant literature is reviewed. The following conclusions were drawn from the present study and review of the literature. PNET may manifest itself as a primary lesion of the spine unlike the more common drop metastases from an intracranial lesion. PSPNET may be intramedullary, intradural and extradural with variable extraspinal extension. PSPNET may present as holocord intramedullary lesion, an entity which has not been described earlier. These lesions have a short history, significant neurological deficits and rapid course of illness. PSPNET, though an established entity, did not find a place in the WHO 2000 classification of CNS tumors. Hence its status has to be defined. Copyright © 2007 S. Karger AG, Basel

## Introduction

With the increasing awareness and use of immunohistochemistry (IHC), primary spinal primitive neuroectodermal tumor (PSPNET) is increasingly reported. PSPNET is an extremely rare lesion, and only 25 cases have been reported in the world literature so far. Of the 25 cases, 20 have been reported during the last 8 years, though the concept of PNET was described as early as in 1973 [1]. PNET is a broad term that encompasses all embryonal tumors in the CNS that are composed of undifferentiated or poorly differentiated neuroepithelial cells which may have divergent differentiation including neuronal, astrocytic, ependymal, muscular or melanocytic cell lines [2]. Though the clinicoradiological profile and course of PNET are variously described for cranial tumors, little literature is available on PNET of the spine. We report 3 cases of PSPNET and describe the clinical, pathological and radiological characteristics and the outcome of these lesions. We also review the literature with a stress on the evolution and existing controversies of PNET.

#### **Material and Methods**

Three diagnosed cases of PSPNET were reviewed retrospectively in view of their rare pathology. These 3 children were managed in our department between January 2002 and December

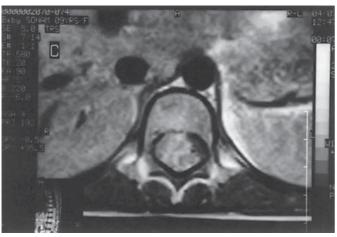

2004. The records of the 3 cases were well maintained in view of their rarity. Clinical profiles of all 3 cases were retrieved from computer database and case files. Follow-up of all 3 cases was maintained by the operating surgeon. A brief summary of the 3 cases is presented below. Cranial imaging of all 3 children was carried out postoperatively to rule out the dissemination from intracranial lesions. Two children received craniospinal radio-therapy postoperatively. The safe doses of radiation were calculated by weight and age of both cases. These 2 children were treated by adjunctive chemotherapy followed by vincristine, cisplatin and CCNU for 8 cycles with an interval of 4–6 weeks between each cycle. One child (case 2) did not receive postoperative radio-therapy/chemotherapy on account of financial reasons.

#### **Case Reports**

#### Case 1

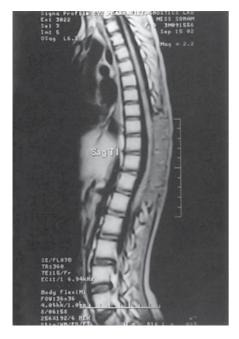
A 9-year-old girl presented with progressive numbness and weakness of both lower limbs of 2 months duration preceded by a bout of low-grade fever for 10–15 days. There was also a history of progressive thinning of the right lower limb for 4 weeks and the left lower limb for 2 weeks. The patient had become bedridden due to the weakness. There was no history of bladder or bowel involvement. On examination, wasting and decreased tone were noted in both lower limbs. Power in the proximal muscle groups of the right lower limb was Medical Research Council (MRC) grade 2/5, distally 0/5 and on the left side proximally 3/5 and distally 2/5. There was 30% hypoesthesia below the  $D_8$  level with no sensory dissociation or sacral sparing. MRI of the spine revealed a heterogeneously enhanced lesion isointense on  $T_1$ - and hyperintense on  $T_2$ -weighted images which was expanding the cord opposite  $D_9$  to the L<sub>1</sub> vertebral level (fig. 1, 2). The differential diagnosis of ependymoma and astrocytoma was considered. At surgery, a subpial lesion was seen which had a poor plane of cleavage from the rest of the cord tissue. The tumor was soft grayish, vascular, suckable at places, compressing and shifting the cord to the left. Gross total decompression was done (fig. 3). Postoperatively there was partial improvement in the deficits. Histopathology of the lesion revealed PNET. A cranial screening CT scan was done which did not reveal any lesion. The child received craniospinal radiotherapy and chemotherapy. There was no progression of the disease at the end of 18 months.

#### Case 2

An 8-year-old boy presented with a painful neck swelling on the right side of the neck of 5 months duration followed by progressive spastic quadriparesis with distal to proximal progression with no bladder or bowel involvement of 1 month duration. The child had become bedridden for 15 days. On examination tone was increased in all the limbs except in the right upper limb. Power in the right upper limb was MRC grade 0/5 and in the remaining limbs it was MRC grade 2-3/5. MRI revealed an extramedullary lesion with extradural spread along the neural foramen, which was isointense on T<sub>1</sub>- and hyperintense on T<sub>2</sub>-weighted images, which was extending from the C  $_2$  to C  $_4$  vertebral level placed on the right side (fig. 4). A provisional diagnosis of neurofibroma was made. Through a C1-to-C4 laminectomy, a gross total excision was achieved. The tumor was soft, vascular, completely extradural and infiltrating the exiting C2 and C3 nerve roots and also the neck muscles. Histopathology revealed it as PNET. By the seventh postoperative day, the patient was ambulatory without support. Due to socioeconomic problems the patient did not receive any adjuvant therapy and had a recurrence of symptoms at 8 months with reappearance of myelopathy.

#### Case 3

An 18-year-old male presented with progressive dorsal pain and progressive weakness of both lower limbs for 4 months and of the upper limbs for 3 months. Because of weakness the patient had become bedridden for 3 months. He had also been urine and stool incontinent for 2 months. On examination, there was hypotonia in all the limbs. Power in the upper limbs was MRC grade 3/5 and in the lower limbs 0-1/5. Below  $C_2$  the boy had a hypoesthesia of 50-60% and a decreased anal tone.

On MRI, the cord was expanded from  $C_3$  below. Multiple hypointense spots on  $T_1$ - and  $T_2$ -weighted images were seen throughout the cord suggestive of flow voids. Since the lesion appeared to be either arteriovenous malformation or hemangioblastoma, spinal angiography was done to rule out the vascular lesion/mass. There was patchy enhancement of the entire cord (fig. 5) with an area of relatively intense enhancement at the  $D_5$  vertebral level. Through a  $D_4$ -to- $D_7$  laminectomy, an intramedullary lesion was noted which was vascular with exophytic areas into the intradural space. It was very vascular and only a biopsy could be taken, which revealed PNET (fig. 6, 7). The patient received radiotherapy and chemotherapy, and there was stabilization of symptoms at 6 months of follow-up.

## Discussion

On searching Pubmed, 25 cases have been reported so far. An overview is given in table 1.

# *Evolution of the Concept of PNET and Its Present Status*

Hart and Earle [1] introduced the term PNET in 1973 to describe pediatric cerebral neoplasms largely consisting of undifferentiated cells that did not fit into any of the classes described by Rubenstein [2]. The concept was broadened by Rorke [22] who classified all CNS tumors with a predominant undifferentiated primitive cell component including medulloblastoma as PNET. This broad view has been further refined concerning the type of differentiation. However, the widely accepted recent WHO (2000) classification avoids controversy by including only those supratentorial embryonal tumors that cannot be grouped under ependymoblastoma or pineablastoma. This classification – though very extensive and comprehensive – makes no mention of PSPNET. The next revision of the WHO classification of CNS tumors may include the well-established entity of PSPNET.

# Characteristic Pathology

*Histopathology of PNET and IHC.* (1) Poorly differentiated small round/spindle-shaped cells. (2) Architecture: either densely packed or placed in sheets or nests. (3) Cells are generally positive for neuronal markers like neuron-specific enolase; it could be for precursor intermediate filaments like nestin, vimentin or microfilaments; synaptophysin or GFAP may be positive depending on the differentiation of the cells; S-100 is also commonly positive. (4) In case of undifferentiated cells, they may not stain positive for any analyses.

The cell of origin is still not defined whether it is an internal granule cell of the cerebellum or an undifferentiated cell common to all portions of the nervous system [23].

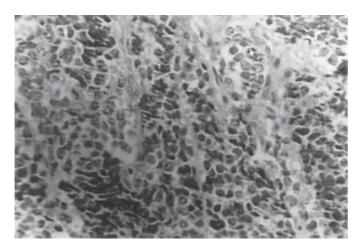
The revised WHO classification of CNS tumors which was expected in 2005 should help in resolving the present controversy, as with the routine use of IHC and electron microscopy, more data will be available in days to come.

# Primary Spinal PNET

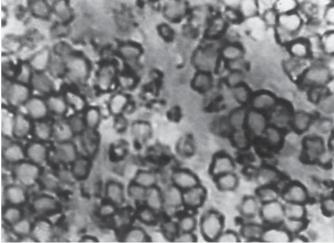
PSPNET can occur in any group. The age range is 3 months to 69 years. The mean age is 24 years. Because this

is much older than the average age of manifestation of intracranial PNET, spinal PNET appears to be more common in adults than in children. All our 3 patients were children (<20 years). There is a slight male predominance (18 out of 28). It can involve any part of the spine and can be intra- or extradural. Two of our patients had intramedullary and the other had extradural lesions. One of our patients had a holocord involvement which has not been reported before (case 3).

Like other malignant spinal lesions, history is short. All cases had had symptoms for less than 4 months. This

short history has been characteristic of PSPNET and is in accordance with the other reported cases. At no stage of the illness did the patients show any evidence of cranial lesion. This is important since most cases of PNET involving the spinal cord are 'drop' metastases from primary intracranial tumors. It has been postulated that the primary intracranial lesion may be small and clinically silent, with symptoms referable only to the metastatic deposits of the spine. One case of intramedullary drop metastases with no leptomeningeal involvement has been described. All our patients underwent cranial imaging postoperatively with no evidence of any pathology.

There are no specific features of these tumors on MRI. In case 1, the lesion was intramedullary and heterogeneously enhancing on contrast and appeared to have pushed the cord eccentrically to the left. A preoperative diagnosis of ependymoma was made.

In case 2, imaging gave a picture akin to a neurofibroma since it had intra- and extradural involvement. Case 3 was truly a diagnostic dilemma. The cord was diffusely enlarged with some patchy contrast enhancement except at the  $D_5$  level which had intense enhancement. This picture may resemble holocord astrocytoma to some extent. Holocord hemangioblastoma differed from it in many ways. There was no cyst, and multiple flow voids were seen. A spinal angiogram did not reveal any increased vascularity of the enhancing portion. A review of the literature showed no specific characteristics described for PSPNET. MRI findings are not specific and can mimic other spinal lesions. But this holocord involvement with multiple flow voids has not been described earlier in

the literature. Only 4 cases have been extradural and the rest were intradural. The commonest location is the cauda equina region. This might be due to the fact that the cauda equina forms part of the peripheral nervous system, where the axons have become dependent on Schwann cells for the maintenance of their myelin sheaths.

These cases are diagnosed on histopathology and IHC. IHC was done in all 3 cases to confirm the diagnosis (table 2). Though near total decompression forms the primary mode of treatment, results are poor. Radiotherapy and chemotherapy have been used. In view of the limited cases, the optimal management has not been defined yet. We offered craniospinal radiation in our cases as it is used in cases of posterior fossa medulloblastomas. The cranial radiation was carried out as PNET tumors are known for their widespread dissemination through the CSF [24]. Since we had witnessed supratentorial dissemination in operated and irradiated cases of posterior fossa medulloblastomas, we irradiated the cranium also. The doses of radiation were calculated according to the weight and age of each case. No extra (booster) doses were given to the involved segment. The chemotherapy used by us was the Packer regimen. It consisted of vincristine weekly during radiotherapy and then vincristine, cisplatin and CCNU for 8 cycles [25]. In view of the propensity for metastasis beyond the craniospinal axis, the initial workup should screen the chest and abdomen. Bone marrow aspiration and cytology to look for dissemination is also advised. In view of the poor results with conventional modalities, novel approaches like adoptive immunotherapy are necessary. Peripheral blood stem cell transfusion is suggested during periods of remission [26]. An improvement of the treatment outcome can only be achieved by intensification through a multidisciplinary approach.
