## Striatal infarct with paroxysmal nonkinesigenic dyskinesia

Paroxysmal nonkinesigenic dyskinesia (PNKD) is a rare disorder characterized by episodic hyperkinetic movement attacks of any combination of dystonia, chorea, athetosis, and ballismus. Attacks may be triggered by emotional stress, fatigue or consumption of alcohol and caffeine. PNKD is usually inherited as an autosomal dominant trait [1].

The most common cause of secondary PNKD is multiple sclerosis [1]. However, PNKD has been reported in encephalitis, endocrine dysfunction (hypoglycemia, thyrotoxicosis, hypoparathyroidism), inherited biopterin synthesis defect, head injury, primer antiphospholipid syndrome, and HIV [1]. Symptomatic PNKD has rarely been

reported to be caused by thalamic or subcortical lacunar infarcts [2, 3].




Fig. 1 Infarct in the right nuclei lentiformis and caudatus in T2, T1 weighted and FLAIR sequences of MRI

In this letter, we describe a 45-year-old woman with short-lasting hemidystonia attacks in left side which commenced 3 weeks ago in 2009 (video). The characteristic of onset was abrupt. The episodes occurred 5–50 times per day, lasted from 10 to 30 s, and they rarely occur during sleep, and never precipitated by any factor. There were no other signs or symptoms. Our diagnosis was PNKD. Interictal EEG was normal, which helped us excluding an epileptic seizure. Neuroimaging studies showed a subacute infarct in the right nuclei lentiformis and caudatus (Fig. 1). Factor V Leiden mutation detected in the patient was accepted to be the cause of infarct and attacks have completely disappeared by carbamazepine (800 mg/day).

Symptomatic PNKD is rare and is reported in association with vascular lesions. In 1974, Lee et al. [2] described a PNKD with thalamic ischemia. Norlinah and Shahizon reported two patients with subcortical white matter ischemia. One of them presented with paroxysmal kinesigenic dyskinesia and the other was PNKD [3].

Alemdar et al. reported a PNKD with hypoparathyroidism. Neuroimaging studies showed calcifications in the basal ganglia, thalamus, brain stem, subcortical and cerebellar regions [4]. Basal ganglia and striatal lesions had been reported with PNKD [5]. Lesions in basal ganglia were similiar to the neuroimaging findings of our case.

Although PNKD was reported to be associated with transient ischemic attacks, thalamic or subcortical lacunar infarcts, the presented patient were associated with an infarct of striatum [1–3]. We could rarely find similar reported relationship in our literature survey. Moreover, it has rarely been reported to be caused by lacunar infarcts.
