# Progressive intervention strategy for the gait of sub-acute stroke patient using the International Classification of Functioning, Disability, and Health tool

#### 10 Abstract.

11 BACKGROUND: The International Classification of Functioning, Disability, and Health (ICF) provides models for functions

and disabilities. The ICF is presented as a frame that enables organizing physical therapists' clinical practice for application.

- **OBJECTIVE:** The purpose of the present study was to describe processes through which stroke patients are assessed and treated based on the ICF model.
- METHODS: The patient was a 65-year-old female diagnosed with right cerebral artery infarction with left hemiparesis.
- Progressive interventions were applied, such as those aiming at sitting and standing for the first two weeks, gait intervention for the third and fourth weeks, and those aiming at sitting from a standing position for the fifth and sixth weeks.
- 18 **RESULTS:** The ICF model provides rehabilitation experts with a frame that enables them to accurately identify and understand
- their patients' problems. The ICF model helps the experts understand not only their patients' body structure, function, activity,
- <sup>20</sup> and participation, but also their problems related to personal and environmental factors.
- CONCLUSIONS: The experts could efficiently make decisions and provide optimum treatment at clinics using the ICF
   model.

# 24 **1. Introduction**

Physical therapists make great efforts to maximize
their patients' functional and motor abilities at clinics.
Physical therapists should not only collect and analyze pieces of information related to identifying their

patients' problems, but also make decisions on what problems they should solve and how to solve them to plan the most effective intervention. Therefore, the therapists' decision-making ability about evaluation and intervention is the most important attribute that affects intervention results. Decision making means the critical thinking necessary for therapists to provide the most effective intervention and problemsolving processes (Wainwright, Shepard Harman, & Stephens, 2011). Therefore, the treatment and intervention in physical therapy are problem-solving processes and not acts of applying treatment meth-

ods known by therapists. Clinical reasoning processes
are necessary for therapists to make wise decisions in
these processes.

Clinical reasoning is clinical practice related to 44 therapists' thinking and decision-making that enable 45 them to perform the wisest acts (Jones & Rivett, 46 2004). Clinical reasoning processes enable therapists 47 to prepare problem lists, decide problem priorities, 48 and set meaningful goals and purposes to pro-49 vide the most efficient intervention. A conceptual 50 framework is necessary as a logical tool to imple-51 ment clinical practices concretely and systematically. 52 The conceptual framework provides therapists with 53 guidelines on how to proceed with interventions at 54 clinics and is composed of practice and disability 55 models, hypothesis-oriented clinical practices, and 56 motor control theories (Shumway-Cook & Woolla-57 cott, 2007). The World Health Organization presented 58 the International Classification of Functioning, Dis-59 ability, and Health (ICF) to describe health-related 60 conditions (WHO, 2001). The ICF has been recently 61 reported as being applicable as a framework to 62 direct and organize treatments of patients and clients 63 (Coffin-Zadai, 2007; Jette, 2006). In addition, the 64 ICF well integrated evidence-based principles of 65 practices, multidisciplinary circulation, and other 66 models such as clinical reasoning models (Run-67 dell, Davenport, & Wagner, 2009). This means that 68 the ICF is used as a useful tool at clinics. The 69 present study describes intervention strategies for 70 gaits of patients with sub-acute stroke using the 71 tool ICF. 72

Stroke patients' gait difficulties appear as dif-73 ficulties in balance and postural control due to 74 damage to the central nervous system and dis-75 abilities in symmetrical motor control (Dijkerman, 76 Letswaart, Johnston, & MacWalter, 2004). Two thirds 77 of stroke survivors have gait disabilities, and the most 78 common gait characteristics compared with normal 79 persons are decreased gait velocity and stride lengths 80 and asymmetry between the two lower extremities 81 (Shaughnessy, Michael, Sorkin, & Macko, 2005; 82 Brunt, Vander Linden, & Behrman, 1995; Roerdink 83 et al., 2007). In addition, compensatory acts of the 84 non-paretic side that tended to compensate inade-85 quate paretic extremity motor control are mainly 86 observed (Brunt, Vander Linden, & Behrman, 1995; 87 Bensoussan, Mesure, Viton, & Delarque, 2006). The 88 consequent abnormal gaits show adverse effects on 89 stroke patients' ability to perform independent daily 90 living activities and the prognosis (Barbeau & Vis-91 intin, 2003; Hesse, Schroeder, Heller & Kroll, 2000). 92

Therefore, stroke patients' independent gait ability is one of factors that are considered most intensively in functional recovery (Mauritz, 2002).

The ICF is a tool that can help therapists not only to understand information on patients' health and health-related conditions and assess patients' functional problems, but also to provide interventions at clinics that can be effectively used in clinical-reasoning processes. However, most therapists not only do not comprehend patients' problems using standardized term at clinics, but also do not prepare intervention strategies necessary for problem solving. Therefore, the purpose of the present study is to present processes to examine and assess patients' functional problems, measure the results using the ICF tool, and prepare intervention strategies, thereby contributing to future changes in clinical practices.

### 2. Case description

The patient was a 65-year-old female who was a 112 full-time homemaker. Her height and weight were 113 167 cm and 67 kg, respectively. She was diagnosed 114 with right lower cerebral artery infarction and showed 115 left hemiparesis. She directly came to the hospital 116 acute care. She was showing general muscle weak-117 ness since the onset of stroke five months prior. She 118 was being treated at the rehabilitation center of W 119 University Hospital as an inpatient and had no par-120 ticular past medical history. She was taken care of 121 by a caregiver in the morning and by her husband 122 and son in the afternoon during her hospital stay. The 123 husband came only during afternoons because he was 124 working, and sometimes her son, who was a univer-125 sity student, came to care for her. As for the patient's 126 demands and perspective, the patient said, "I want to 127 recover as soon as possible and cook and do house-128 keeping work at my home" and advised that she was 129 performing self-exercise for at least two hours per 130 day together with the caregiver to improve her sit-131 uation. She was highly adaptable to treatment and 132 performed all tasks related to self-exercise given to 133 her. The goal that she wanted to achieve the most was 134 "walking without being helped," and she said that she 135 felt the best when she was walking. As for the sup-136 port and attitudes of the patient's family members, 137 their economic level had a positive effect on reha-138 bilitation processes, support was active, and family 139 relations were harmonious. The patient was taking 140 drugs for depression, liver, intestine, and urogenital 141

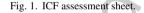

organ diseases. This study received approval from the
Yonsei University Wonju Institutional Review Board
and the study obeys the relevant regulations including Bioethics and Safety Act (Registration number:
1041849-201604-BM-019-02).

#### 147 **3. Clinical Impression**

The patient's detailed information was classified using an ICF model (Fig. 1). Physical function and structural disabilities and participation restriction in activities were recorded, and the correlations among individual factors were calculated.

#### 153 **4. Examination**

Diverse assessment tools were used to objectively assess the information on the subject using the ICF model.

157 1) Measurement of difficulties and confidence

The patient's difficulties and confidence were measured using the outpatient physical therapy improvement in movement assessment log (OPTI-MAL), and based on the results, the degrees of difficulties and the confidence were 96 and 108 points, respectively (Guccione et al., 2005). The assessment was conducted by interviewing the patient. Higher scores indicate lower degrees of difficulties and confidence felt by the patient, and lower scores indicate higher degrees of difficulties and confidence in performing actions.

2) Balance ability test

Balance ability tests were conducted using a balance ability motor treatment system (TETRAX, Sunlight Medical Ltd, Israel) and the Berg balance scale. The fall index of TETRAX is distributed between 0 and 100 points, and higher scores indicate higher fall incidence rates (low fall risk, 0–35; moderate fall risk, 36–57; high fall risk, 58–100) (Akkaya et al., 2015). The patient showed a fall risk score of 100 points at the initial assessment. The sensitivity and specificity of fall risks were.76 and.60, respectively 158

(Laufer, Sivan, Schwarzmann, & Sprecher, 2003). The 180 Berg balance scale gives individual item scores rang-181 ing from 0 to 4 points. The total score is 56 points, 182 and higher scores indicate better balance ability (Berg, 183 Wood-Dauphinee, & Williams, 1995). Points 0-20, 184 21-40, and 41-56 indicate high, moderate, and low fall 185 risks, respectively. The subject showed high fall risks 186 with a score of 17 points at the beginning (Badke, Shea, 187 Miedaner, & Grove, 2004).

3) Gait ability test

The subject's gait ability was assessed using the 190 10-m walk test (Dean, Richards, & Malouin, 2001). The 10-m walk test was composed of a 14-m gait 192 path made by connecting two points linearly using 103 two 10-cm-wide tapes. Marked lines were made 194 at points 2 m away medially from the two ends 195 of the 14-m gait path. The 2-m distance at the 196 beginning and end was set for acceleration and deceleration, and the walking time for 10 m in the middle 198 of the gait path was measured using a stopwatch 199 and used as a measurement variable for functional 200 gaits.

5. Application of the ICF Model 202

1) Comprehending functional problems

To collect the patient's functional problems, the patient's ability and performance capability were comprehended during activities and in the area of participation using ICF core set, and environmental and personal factors that affected the ability and performance capability were codified using the ICF, and the correlations between the factors were comprehended.

(1) Limited activities and restrictions on 212 participation 213

- The patient had no limitation or restriction in 214 the areas of learning or knowledge application 215 (d1.00). 216
- he patient had serious restrictions on perfor-217 mance and ability in the areas of general duties 218 and demands (d2.33). 219
- The patient had no limitation or restriction in the 220 area of communication (d3.00). 221
- The patient could not take a squatting position 222 (d4101.33). 223
- The patient could not sit and stand up 224 (d4103.23). 225
- The patient had difficulties in standing 226 (d4104.22). 227

- The patient had difficulties in bending (d4105.44).
- The patient could not shift her weight (d4106.12). - The patient could not move from her wheelchair to a mat (d420.23).
- Although she could not independently walk, she could walk with the assistance of a walker and being assisted (d4500.23).
- She could not walk a long distance (d4501.44).
- She had difficulties in walking on uneven grounds (d4502.33).
- She had difficulties in walking around a barrier (d4503.33).
- She had difficulties in ascending (d4551.34).
- She could not run (d4552.44).
- She could not move to a different place (d460.33).

(2) Environmental and personal factors

As for environmental factors, the patient was being actively supported by her family members (e310. +3). In addition, as for personal factors, she actively participated in treatment and wanted to return to society as soon as possible with her mind full of will.

2) Decision-making process

(1) Patient's demands and selection of priorities of problem solving

The patient reported, "I want to recover as soon as possible and cook and do housekeeping work at my home" and said that she should be able to walk fast. Among others, she wanted to walk without assistance. Based on these patient demands, a problem to be solved was independent gait with agreement from the patient. In addition, short-term problems to be solved for independent gait were forward weight shifts, independent sitting and standing, and independent walking with the assistance of a walker.

(2) Preparation of a problem list and priority selection

A list of problems to be solved related to the long-term goal "independent gait" was prepared, and information from the ICF assessment sheet and videos from patient's movements were observed and analyzed to determine priorities. The list of problems related to independent gait included the inability to sit and stand, to walk independently, and to sit safely on a chair, and their priorities and whether related tasks were performed were comprehended. Based on the results, the first, second, and third priorities were the inabilities to sit and stand up, walk independently, and sit safely on a chair, respectively, and no tasks related to the items could be performed.

Goals were set to solve the long-term and related short-term problems agreed with the patient. The goals were set before the commencement of interventions for individual short-term problems through agreement with the patient. Problems that were judged as solvable in a short period were selected based on the prepared problem list to achieve the short-term goals agreed with the patient in setting the detailed goals and purposes as follows.

To achieve the first goal of "independent sitting to standing", a detailed goal was set as "when trying to stand up, bend the upper body forward so that the hip can be lifted from the chair," and related purposes were set as "bring the feet backward," "bend the trunk forward stably," and "shift the weight forward."

To achieve the second goal of "making independent gait possible", a detailed goal was set as "walk without assistance," and related purposes were set as "thrust forward during walking," "shift the weight toward the affected side," and "improve the balance ability."

To achieve the third goal of "sitting on a chair independently," a detailed goal was set as "sit safely on a chair independently," and related purposes were set as "increase the ability to control the lower extremities and muscle strength" and "improve the balance ability".

(4) Hypothesis setting

Based on the problem-centered learning method for achievement of the set goals, the problems that would be subjected to interventions were recorded. In addition, knowledge related to the comprehended information was obtained first through many studies and books, and hypotheses were set thereafter. The problem-based learning processes were implemented three times based on the short-term goals set to achieve the long-term goals. The set hypotheses were detailed intervention methods based on individual detailed goals, considering correlations and the possibility to solve problems (Tables 1–3).

6. Intervention

Interventions were progressively applied for sitting to standing, gait, and sitting, considering the relationships of the set goals. The interventions for sitting and standing, gait, and sitting were not applied one by one, but another intervention was added when one intervention was being implemented according to the degree of improvement of the patient's functions. The overall exercises applied were task-oriented approach-based treatments and treatments obtained through therapists' experiences. When the patient felt severe fatigue, rests were given between different exercises. Attention was paid during exercises not to cause pain or danger. The intervention methods implemented in the present study are presented in Tables 1-3. We developed new problem-based learning notes for intervention of physical therapy based on Hmelo-Silver (2004)'s study. The facts column provides information that the physical therapists gathered from the patient such as functional movement and posture. The hypothesis column provides information, wherein the physical therapists place their questions for solving problems in different ways. The intervention column keeps track of plans

for resolving the problems. The need-to-know col umn provides pieces of information for establishing
 hypothesis and planning intervention.

## 347 7. Outcomes

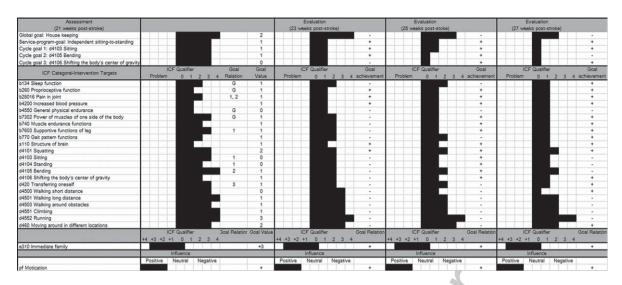


Fig. 2. ICF evaluation display: sitting to standing, gait and sitting. Qualifier ranges from 0 = no problem to 4 = complete problem in the components of body functions (b), body structure (s), activity and participation (d), and from 4 = complete barrier to +4 = complete facilitator in the environmental factors. In personal factors, the signs + and – indicates to what extent a determined personal factor (pf) has on the positive or negative influence on the individual's functioning. 1, 2, and 3 show the relation to cycle goals 1, 2, and 3; G is related to the global goal.

Information was collected from the patient using
 observation and analysis of the ICF core set and
 videos. In addition, problems were analyzed to set
 intervention goals and implement interventions based
 on the collected information. Instead of intensively

treating one problem, interventions were progressively applied according to the improvement of the patient's functional ability. In addition, the patient's functions were assessed before implementing the interventions using the ICF evaluation display (Kirschneck, Rauch, Stucki, & Cieza, 2011). This way, the overall degree of functional improvement could be identified (Fig. 2).

1) Measurement of difficulties and confidence

Based on the results of measurement using OPTI-MAL, the degrees of difficulties and confidence were improved by 41 and 69 points from 96 and 108 points

before intervention to 55 and 39 points after intervention, respectively.

# 2) Balance ability test

Balance ability was measured in two ways before intervention. In fall risk measurement using TETRAX, a high fall risk was shown with a score of 100 points, and the fall risk was decreased to moderate with a score of 42 points after intervention. The fall risk improved from high to moderate, in the Berg balance scale from 17 to 25 points.

3) Gait ability test

The gait ability of the patient could not be measured at the beginning because the patient could not walk. However, the patient could walk with a Q-cane after the intervention for approximately two months, and a 10-m walk test was completed in 48 s.

## 381 8. Discussion

In the present study, the stroke patient's func-382 tional problems were identified using an ICF core 383 set and after intervention were comprehended using 384 the ICF evaluation display and objective assess-385 ments. Therapists in the clinics should be able to 386 accurately comprehend patients' functional prob-387 lems and present the most efficient methods of 388 solving these problems. Comprehending patients' 389 functional abilities is finding out changes in the 390 patients' body function and structure, the level of 391

their capacity for activities and participation, and how they perform the activities and participation. In addition, therapists should comprehend promoting and impeding factors that affect functional ability, considering the environmental and personal factors. Patient's problems can be identified at the holistic level based on the patient's health conditions and personal and environmental factors by applying the ICF to clinical practices (Helgeson & Smith, 2008).

The ICF model is useful for rehabilitation experts to assess patients' functions and disabilities and interactions between individual factors (WHO, 2001). The purpose of the ICF core set is to provide brief ICF core set that is the minimum standard made by extracting appropriate items out of all ICF items for common use in clinical studies and treatment and comprehensive ICF core set that can be used by many experts for comprehensive assessment and reporting of health and functions (Geyh et al., 2004). In addition, the ICF assessment sheet assists diagnostic processes to identify the relationships between problems set as hypotheses and the causes of these problems in clinical-reasoning processes (Rauch et al., 2010). The evaluation display can be used as data for discussion with experts in multiple areas because it includes goals and intervention targets and can clearly present changes in functional conditions before and after intervention (Rentsch et al., 2009).

In the present study, interventions with different 422 targets in relation to patient's problems were pro-423 gressively applied at intervals of approximately 2 424 weeks. A top priority problem to be solved was set 425 as "independent sitting to standing" because it was 426 judged to be a prerequisite target that was indis-427 pensable to achieve "independent walking," which 428 is the ultimate and long-term goal of the patient. 429 "Walking", and "sitting" tasks were set and applied 430 after "independent sitting to standing" was achieved. 431 The pieces of information necessary to solve the 432 patient's problems were organized based on the ICF 433 core set, and the comprehended problems and goals 434 that must be achieved were organized using the eval-435 uation display. In addition, balance ability and gait 436 ability were assessed using the Berg balance scale 437 and TETRAX and 10-m walk tests, respectively. The 438 patient's improvement could be quantitatively com-439 pared using these assessment tools. 440

The interventions applied in the present study 441 were treatment methods based on therapists' expe-442 riences and task-oriented approaches. Task-oriented 443 approaches are training methods that help func-444 tional organization by repeated training on activity 445 tasks related to daily living based on motor learn-446 ing, which can draw functional movements more 447 easily by motivation (Blundell et al., 2003). In addi-448 tion, interventions were applied based on therapists' 449 experiences and diverse kinds of evidence. Because 450 interventions were aimed at sitting to standing, inter-451 ventions related to the evidence indicates that the 452 subject should be able to sufficiently bring the feet 453 backward, extend the trunk and move it forward, and 454 make coordinated movements (Busse, 2003; Janssen, 455 Bussmann & Stam, 2002). Because sufficient lower 456 extremity muscle strength, thrust necessary for move-457 ments in the desired direction, basic gait rhythm 458 generation, balance control during trunk movements, 459 and flexibility are necessary, these were consid-460 ered for interventions aimed at walking (Barbeau & 461 Vinstin, 2003; Busse, 2003; Forssberg & Nashner, 462 1982; Kilbreath, Perkins, Crosbie, & McConnell, 463 2006). Because balance and coordinating abilities 464 and trunk stabilization are necessary, these were con-465 sidered for interventions aimed at sitting (Kralji, 466 Jaeger, & Munih, 1990). 467

In the present study, hypotheses were set and verified based on such knowledge. Based on such knowledge and evidence, the priorities of problems that could be solved were determined, and related intervention purposes and goals were set to apply the interventions. In the present study, short-term purposes and goals were set for long-term goals and interventions, unlike general intervention reports where many interventions are applied to one purpose or goal, were progressively applied, which is quite meaningful.

A limitation of the present study was that this is a case study; thus, the findings of this study cannot be generalized. However, the authors contend that the present study is quite significant because this study progressively presented diverse interventions in accordance with concrete goals after analyzing correlations among patient's functional problems instead of general intervention processes that have been implemented traditionally for stroke patients.

9. Summary

In the present study, functional problems of the sub-acute stroke patient were identified using the ICF core set, and the priorities of the problems were determined to progressively apply interventions. The use of the ICF model enabled general functional assessment of the patient and the application of appropriate goals and interventions. These interventions for patients using the ICF model were advantageous in that diverse functional problems and their correlations could be accurately addressed.
